Although the Registrant is waiting for the financial statements of its Hong Kong Joint Venture before it is able to finalize the Registrant's financial statements, the trend of the Registrant's results of operations for the fiscal year ended March 31, 2014 has continued in lower sales and net losses for the fiscal quarter ended September 30, 2014. However, included in the results of operations of the Registrant's prior year period (the fiscal quarter ended September 30, 2013), was the fully reserving of a \$2,479,901 deferred tax asset. As a result, the Registrant anticipates that its loss from operations for the 2014 period will be significantly higher than its loss from operations for the corresponding 2013 period, but that its net loss for the 2014 period will be significantly less than its net loss for the corresponding 2013 period. The Registrant is unable to quantify the loss from operations and net loss for the three months ended September 30, 2014 without the information contained in the Hong Kong Joint Venture financial statements, and accordingly, at this time, is unable to provide a reasonable estimate of the anticipated changes in loss from operations and net loss compared to the prior period at this time.
