(1) Represents the difference between 21,108 performance-based shares of Restricted Common Stock that vested on January 9, 2011 and 10,554 performance-based shares of Restricted Common Stock whose grant was originally reported on a Form 4 filed with the U.S. Securities and Exchange Commission on January 11, 2008 (the "Original Form 4"). As reported on the Original Form 4, such performance-based shares were originally granted to the Reporting Person on January 9, 2008 under the 2006 Stock-Based Incentive Compensation Plan and were to vest on January 9, 2011 based on the Company's Total Shareholder Return versus a defined group of companies, which the final number of performance-based vested shares varying from 0 to 200% of 10,554.
