(1) The Reporting Person was granted 126,619 shares of Restricted Common Stock under the 2013 Stock-Based Incentive Compensation Plan. 44,666 shares vest over a three year period as follows: 14,889 shares on January 3, 2015 and January 3, 2016, respectively, and 14,888 shares on January 3, 2017. The final 81,953 shares vest on January 3, 2017 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance based vested shares varying from 0 to 200% of 81,953.
