- (1) The Company made a profit sharing contribution in Company common stock to its 401(k) plan at the close of business on 12/18/07 but the plan administrator did not credit the accounts of the participants until 12/27/07. Participants were not informed of the actual contribution until after 12/27/07 which gave rise to the initial late filing. This amendment amends the initial filing to show the correct date of grant as 12/18/07.
- (2) Profit Sharing Contribution Discretionary profit sharing contribution made in company stock and deposited into the employee's 401(k) account. The profit sharing contribution becomes 100% vested following three years of employment.
