- (1) There was a 10% stock dividend on September 30, 2016, and a \$0.05 cash dividend for which Mr. Hughes receives additional shares.
- (2) Mr. Hughes had 8,490 stock options that were granted on 1/25/2007 and expire on 1/25/2017. The company did a "net-out" of those shares based on the stock price of \$13.30 resulting in the issuance of 1,162 common shares.
- (3) 8,490 stock options were granted on 1/25/07, which vest 1/3 each year commencing 1/25/08; 1/25/09; and 1/25/10 and expire on 1/25/17. Mr. Hughes received 1,162 shares of common stock through a "net-out" with the Company on 11/16/2016.
- (4) 44,550 stock options were granted to Mr. Hughes of which 22,550 are currently exercisable.
