**(a) Amount Beneficially Owned:**

As of the date of this filing, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), is the beneficial owner of 4,030,806 shares of the Company's Common Stock, of which 200,000 shares are a constituent part of the Company's units. Each unit consists of one share of Common Stock and one warrant ("Unit"). Each warrant will entitle the holder to purchase one share of the Company's Common Stock at a price of \$7.50 ("Warrant"). Each Warrant will become exercisable upon the Company's completion of a business combination. Note: No Warrant will be exercisable and the Company will not be obligated to issue shares of Common Stock unless, at the time a holder seeks to exercise a Warrant, the Company has a registration statement under the Securities Act in effect covering the shares of Common Stock issuable upon the exercise of the Warrants and a current prospectus relating to the shares of Common Stock. The Warrants will expire on October 22, 2012, or earlier upon redemption. As of the date of this filing, the Company has not announced the completion of a business combination and therefore, the Warrants are not currently exercisable. In addition to the 200,000 Warrants held as a constituent part of the Units, Integrated Core Strategies also holds an additional 7,060,493 Warrants which are also not currently exercisable.

In addition, as of the date of this filing, Millenco LLC, a Delaware limited liability company ("Millenco"), is the beneficial owner of 2,244,321 shares of the Company's Common Stock, of which 646,200 shares are a constituent part of the Company's Units.

Note: As of the date of this filing, Catapult Partners, Ltd., an affiliate of the Reporting Persons, holds 980,600 Warrants which are also not currently exercisable.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies, and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Millennium Management is also the manager of Millenco, and may also be deemed to have shared voting control and investment discretion over securities owned by Millenco. Israel A. Englander ("Mr. Englander") is the managing member of Millennium Management. Consequently, Mr. Englander may also be deemed to have shared voting control and investment discretion over securities beneficially owned by Integrated Core Strategies and Millenco. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies and/or Millenco, as the case may be.
