On August 27, 2013, Brendan J. Dugan was appointed to the Boards of Directors of Investors Bancorp, Inc. and Investors Bank, effective as of the August 27, 2013. Mr. Dugan is committed to community involvement and serves on various boards within the community. No determination has been made as to any board committees to which Mr. Dugan may be appointed. There have been no transactions between Investors Bancorp, Inc. (or Investors Bank) and Mr. Dugan of a nature reportable pursuant to Section 404(a) of SEC Regulation S-K.

On August 27, 2013, the Boards of Directors of Investors Bancorp, Inc. and Investors Bank were expanded to eleven directors and twelve directors, respectively.
