OF THAT AMOUNT, 280 PHANTOM SHARES ARE SUBJECT TO A 5 YEAR CLIFT VESTING AND VEST 12/31/2013. QUARTERLY COMPANY MATCHES WERE ERRONEOUSLY REPORTED AS ACQUIRING PHANTOM SHARES AT 100% RATHER THAN 50%. THE SHARES OF PHANTOM STOCK BECOME PAYABLE, IN CASH OR COMMON STOCK, AT THE ELECTION OF THE REPORTING PERSON, UPON THE REPORTING PERSON'S TERMINATION OF SERVICE.
