Conifer Holdings, Inc. (the "Company") held its 2018 Annual Meeting of Shareholders (the "Annual Meeting") on May 16, 2018. Matters voted upon at the Annual Meeting were: (i) election of two members of the Board of Directors for terms expiring in 2021; and (ii) ratification of the appointment of Deloitte & Touche, LLP as the Company's independent registered public accounting firm for 2018. For more information about the aforementioned proposals, see Conifer's Proxy Statement dated April 4, 2018. As of the March 19, 2018 record date, there were 8,520,328 shares of common stock outstanding and entitled to vote. At the Annual Meeting, 7,843,447 shares, or 92.05%, of the common stock were represented in person or by proxy, constituting a quorum. The certified results of the matters voted on at the Annual Meeting are set forth below.

Proposal No. 1 - Election of James Petcoff and Jorge Morales as directors each for a three-year term expiring in 2021.
