- On January 26, 2016, the Issuer and the Reporting Person entered into that certain Option Cancellation and Release Agreement, pursuant to which the parties agreed to the cancellation of certain stock options previously granted to the Reporting Person in exchange for one (1) share of common stock as consideration.
- (1) Reflects a 1-for-10 reverse stock split effected October 1, 2015.
- (2) This option was previously reported as covering 365,223 shares at an exercise price of \$1.232 per share, but was adjusted to reflect the 1-for-4 reverse stock split that occurred on December 21, 2012 and the 1-for-10 reverse stock split that occurred on October 1, 2015.
- (3) This option vested in three equal annual installments that began on November 24, 2010.
- (4) This option was previously reported as covering 300,000 shares at an exercise price of \$0.8 per share, but was adjusted to reflect the 1-for-4 reverse stock split that occurred on December 21, 2012 and the 1-for-10 reverse stock split that occurred on October 1, 2015.
- (5) This option vested in three equal annual installments beginning on May 25, 2013.
- (6) This option was previously reported as covering 77,000 shares at an exercise price of \$3.1 per share, but was adjusted to reflect the 1-for-10 reverse stock split that occurred on October 1, 2015.
