- (1) Restricted stock units representing the right to receive shares of common stock upon vesting. The restricted stock units vest in three annual installments of 33 1/3% beginning on April 1, 2016.
  - (2) Shares of common stock surrendered to the Issuer in payment of taxes in connection with the vesting and payment of a portion of restricted stock units granted on March 18, 2013 (595 shares) and March 18, 2014 (473 shares), as well as the vesting and pyament of a portion of performance share units granted on March 18, 2013 (234 shares).
  - (3) The option vests in four annual installments of 25% beginning on April 1, 2016.
