Pursuant to the instructions in Item 7 of Schedule 13G, Fidelity Management & Research Company ("Fidelity"), 82 Devonshire Street, Boston, Massachusetts 02109, a wholly-owned subsidiary of FMR LLC and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 5,861,430 shares or 7.435% of the Common Stock outstanding of MasTec Inc. ("the Company") as a result of acting as investment adviser to various investment companies registered under Section 8 of the Investment Company Act of 1940. The number of shares of Common Stock of MasTec Inc. owned by the investment companies at December 31, 2010 included 25,377 shares of Common Stock resulting from the assumed conversion of \$400,000 principal amount of MASTEC INC CONV 4% 06/15/14 (63.4417 shares of Common Stock for each \$1,000 principal amount of debenture). The number of shares of Common Stock of MasTec Inc. owned by the investment companies at December 31, 2010 included 697,855 shares of Common Stock resulting from the assumed conversion of

\$10,800,000 principal amount of MASTEC INC CONV 4.25% 12/15/14 (64.6162 shares of Common Stock for each \$1,000 principal amount of debenture).

Edward C. Johnson 3d and FMR LLC, through its control of Fidelity, and the funds each has sole power to dispose of the 5,861,430 shares owned by the Funds.

Members of the family of Edward C. Johnson 3d, Chairman of FMR LLC, are the predominant owners, directly or through trusts, of Series B voting common shares of FMR LLC, representing 49% of the voting power of FMR LLC. The Johnson family group and all other Series B shareholders have entered into a shareholders' voting agreement under which all Series B voting common shares will be voted in accordance with the majority vote of Series B voting common shares. Accordingly, through their ownership of voting common shares and the execution of the shareholders' voting agreement, members of the Johnson family may be deemed, under the Investment Company Act of 1940, to form a controlling group with respect to FMR LLC.

Neither FMR LLC nor Edward C. Johnson 3d, Chairman of FMR LLC, has the sole power to vote or direct the voting of the shares owned directly by the Fidelity Funds, which power resides with the Funds' Boards of Trustees. Fidelity carries out the voting of the shares under written guidelines established by the Funds' Boards of Trustees.

Pyramis Global Advisors, LLC ("PGALLC"), 900 Salem Street, Smithfield, Rhode Island, 02917, an indirect wholly-owned subsidiary of FMR LLC and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 1,521,807 shares or 1.930% of the outstanding Common Stock of MasTec Inc. as a result of its serving as investment adviser to institutional accounts, non-U.S. mutual funds, or investment companies registered under Section 8 of the Investment Company Act of 1940 owning such shares. The number of shares of Common Stock of MasTec Inc. owned by the institutional account(s) at December 31, 2010 included 204,282 shares of Common Stock resulting from the assumed conversion of \$3,220,000 principal amount of MASTEC INC CONV 4% 06/15/14 (63.4417 shares of Common Stock for each \$1,000 principal amount of debenture). The number of shares of Common Stock of MasTec Inc. owned by the institutional account(s) at December 31, 2010 included 1,317,525 shares of Common Stock resulting from the assumed conversion of \$20,390,000 principal amount of MASTEC INC CONV 4.25% 12/15/14 (64.6162 shares of Common Stock for each \$1,000 principal amount of debenture).

Edward C. Johnson 3d and FMR LLC, through its control of PGALLC, each has sole dispositive power over 1,521,807 shares and sole power to vote or to direct the voting of 1,521,807 shares of Common Stock owned by the institutional accounts or funds advised by PGALLC as reported above.

Pyramis Global Advisors Trust Company ("PGATC"), 900 Salem Street, Smithfield, Rhode Island, 02917, an indirect

wholly-owned subsidiary of FMR LLC and a bank as defined in Section 3(a)(6) of the Securities Exchange Act of 1934, is the beneficial owner of 615,846 shares or 0.781% of the outstanding Common Stock of the MasTec Inc. as a result of its serving as investment manager of institutional accounts owning such shares. The number of shares of Common Stock of MasTec Inc. owned by the institutional account(s) at December 31, 2010 included 24,108 shares of Common Stock resulting from the assumed conversion of \$380,000 principal amount of MASTEC INC CONV 4% 06/15/14 (63.4417 shares of Common Stock for each \$1,000 principal amount of debenture). The number of shares of Common Stock of MasTec Inc. owned by the institutional account(s) at December 31, 2010 included 443,268 shares of Common Stock resulting from the assumed conversion of \$6,860,000 principal amount of MASTEC INC CONV 4.25% 12/15/14 (64.6162 shares of Common Stock for each \$1,000 principal amount of debenture).

Edward C. Johnson 3d and FMR LLC, through its control of Pyramis Global Advisors Trust Company, each has sole dispositive power over 615,846 shares and sole power to vote or to direct the voting of 544,768 shares of Common Stock owned by the institutional accounts managed by PGATC as reported above.
