(1) Compensation Plan for Directors of Unisys Corporation. Deferred units will be distributed in shares of Unisys common stock either upon the earlier of termination of service or on any date at least two years after the stock units are awarded, as previously elected by the director.

(2) Each restricted stock unit represents a contingent right to receive one share of Unisys Corporation common stock.
