- (1) The shares will vest 25% annually beginning in 2018 through 2021. The Reporting Person has voting and dividend rights on all of these shares, including unvested shares.

- (3) The shares will vest 60% on April 28, 2020 and 40% on April 28, 2022 (assuming employment contract is renewed). The Reporting Person has voting and dividend rights on all of these shares, including unvested.
