On January 2, 2007, Phillips-Van Heusen Corporation completed its previously announced acquisition of substantially all of the assets of Superba, Inc., a privately held manufacturer and distributor of neckwear in the United States and Canada. The company also announced that its neckwear licensee for its IZOD and Calvin Klein brands had agreed to the early termination of the license agreements in a transaction expected to be effective in early February 2007. The neckwear businesses acquired from Superba, as well as the IZOD and Calvin Klein neckwear businesses, are to be operated by the newly formed PVH Neckwear Group.
