CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 2,463,600 shares or 5.6% of the 44,073,000 shares of Ordinary Shares, including American Depositary Shares, believed to be outstanding.
