- (3) The number of RSUs reported is from a grant of 32,142 units granted on 2/1/2016, that has been paid in cash as to 19,285 units on 2/1/2017, and as to 9,642 units on 2/1/2018, and will become payable in cash, unless Navistar elects to settle the RSUs in common stock as to 3,215 units on 2/1/2019.
