("Toys"), an equity method investment in which Vornado owns approximately 32.6% of the common equity as of December 31, 2014. On February 17, 2015, Vornado filed its Annual Report on Form 10-K for the year ended December 31, 2014 with the Securities and Exchange Commission indicating on the cover page that it would file an amendment to its Form 10-K to include Toys' audited financial statements and related disclosures as soon as practicable after they were available.

On March 26, 2015, Toys filed its Annual Report on Form 10-K for its fiscal year ended January 31, 2015. Accordingly, Vornado is filing this Amendment No. 1 on Form 10-K/A (Amendment No. 1) to its Form 10-K, filed on February 17, 2015, to incorporate by reference to this Amendment No. 1, Toys' audited financial statements and related disclosures and to similarly include the consent of Deloitte & Touche LLP, Toys' independent registered public accounting firm with respect to its report on such audited financial statements for the fiscal year ended January 31, 2015.

Except as otherwise expressly noted herein, this Amendment No. 1 does not reflect events occurring after the filing of Vornado's original Form 10-K on February 17, 2015. Accordingly, this Amendment No. 1 should be read in conjunction with Vornado's original Form 10-K.
