- On March 9, 2018, Mr. Charles W. Ergen established a Grantor Retained Annuity Trust ("GRAT"), the Ergen Two-Year March 2018 DISH GRAT (the "Two-Year March 2018 GRAT") and contributed 36,000,000 Class B shares to the Two-Year March 2018 GRAT. The
- (1) Two-Year March 2018 GRAT may elect to convert any or all of its Class B shares into an equal number of Class A shares at any time for no additional consideration. The Two-Year March 2018 GRAT is scheduled to expire in accordance with its terms on March 9, 2020. Mrs. Cantey M. Ergen serves as the trustee of such GRAT.
 - (2) Pursuant to the terms of the Two-Year March 2018 GRAT, 22,036,245 Class B shares were distributed as an annuity to Mr. Ergen on March 11, 2019. Following this distribution, the Two-Year March 2018 GRAT retained 13,963,755 Class B shares.
