On March 13, 2002, the Company entered into a purchase agreement (the Purchase Agreement) with Salomon Smith Barney Inc. in connection with the issuance and sale of 9,400,000 Shares of Common Stock. The Shares of Common Stock are a portion of the \$2.0 billion aggregate principal amount of securities that were registered by the Company pursuant to a registration statement on Form S-3 under Rule 415 pursuant to the Securities Act of 1933, as amended, which registration statement was declared effective on March 2, 2001 (File No. 333-55904).
