(1) Reflects the withholding of shares to satisfy tax payment for shares of Restricted Stock Awards that vested on Mr. Meinz's 3/31/2010 retirement under the Company's 2005 Omnibus Incentive Compensation Plan and 2007 Omnibus Incentive Compensation Plan. Under the terms of the plan, the fair market value of any fractional share of Common Stock not used to satisfy the withholding obligation will be paid in cash at the time the RSA's are settled.
- (2) The option vests in four equal annual installments beginning on December 13, 2002.
