The performance share payout was deferred, with 75% going into Company common stock and 25% going into other mutual funds. Under the terms of the plan, payout deferrals may be deferred into Company common stock or other mutual funds within the Deferred Compensation Plan.

- (2) Performance stock rights represent the right to receive shares of common stock of the Company, in the event certain performance goals are satisfied. These goals are based on Company performance against an established industry benchmark, over a three year performance period. The final award of shares issued can be between 0% and 200% of the target award.
  - (3) These phantom stock units convert to common stock on a one-for-one basis.
  - (4) Unless the participant has selected a later commencement date, distribution of stock and equivalents will commence within 60 days following the end of the calendar year in which occurs the participant's retirement or termination of service.
  - (5) Unless the participant has selected a later commencement date, distribution of stock and equivalents will commence within 60 days following the end of the calendar year in which occurs the participant's retirement or termination of service.
  - (6) The acquired shares represent the portion of the Performance Share award payout that was deferred into Company common stock within the Company's Deferred Compensation Plan.

  - (9) The option vests in four equal annual installments beginning on December 10, 2004.

  - (12) The option vests in four equal annual installments beginning on February 10, 2012.
  - (13) The option vests in four equal annual installments beginning on December 7, 2007.
  - (14) The option vests in four equal annual installments beginning on December 7, 2006.
  - (15) The option vests in four equal annual installments beginning on May 17, 2008.
- Performance stock rights represent the right to receive shares of common stock of the Company, in the event certain performance goals are satisfied. These goals are based on Company performance against an established industry benchmark, over a three year performance period. The final award of shares issued can be between 0% and 200% of the target award.
- (17) Each restricted stock unit represent a contingent right to receive one share of Company common stock.
  - (18) The restricted stock units vest in four equal annual installments beginning on February 14, 2009.
  - (19) The restricted stock units vest in four equal annual installments beginning on February 12, 2010.
  - (20) The restricted stock units vest in four equal annual installments beginning on February 11, 2011.
  - (21) The restricted stock units vest in four equal annual installments beginning on February 10, 2012.
