Mr. Goodwin directly and indirectly owns shares of American, Western and Diversified and disclaims beneficial ownership of shares owned by American, Western and Diversified except to the extent of his respective ownership of those entities.

Mr. Goodwin is the controlling shareholder of TIGI and he disclaims beneficial ownership of shares owned by TIGI and its subsidiaries except to the extent of his respective ownership of those entities.
