The additional shares of restricted stock will vest as follows: 30 shares in even increments over 2 years beginning January 2, 2017, 19 shares in even increments over 5 years beginning October 14, 2019, 11 shares in even increments over 3 years beginning November 30, 2016, 32 shares in even increments over 3 years beginning January 2, 2017, 80 shares in even increments over 4 years beginning January 2, 2017 and 99 shares in even increments over 5 years beginning January 4, 2017.
