- (1) On 11/17/04, John R. Friedery finalized a prepaid variable forward contract (Contract) with a broker dealer (Buyer) relating to the disposition by Mr. Friedery of up to 35,000 shares of Ball Corporation Common Stock (Ball Shares). On 11/16/07, the Settlement Date, the Contract obligated Mr. Friedery to deliver to the Buyer a number of Ball Shares equal to \$1,504,650 (32,902 Ball shares @ \$45.73 each). This transaction was disclosed on a Form 4 filing with the SEC on 11/18/04 and was settled in accordance with its terms through delivery by Mr. Friedery of 32,902 Ball Shares to the Buyer.
