Mr. Eppinger "net exercised" 30,000 options. The options were granted to Mr. Eppinger in February 2006, and were scheduled to expire (1) in February 2016. A total of 24,427 shares were withheld by the Company to satisfy the exercise price and taxes associated with the exercise, resulting in a net issuance of 5,573 shares to, and held by, Mr. Eppinger.
