Autocallable Geared Buffered Securities with Conditional Rebate Linked to the Worst Performing of the S&P 500[®] Index and the Russell 2000[®] Index Due May 27, 2020

The securities offered by this pricing supplement are unsecured debt securities issued by Citigroup Global Markets Holdings Inc. and guaranteed by Citigroup Inc. Unlike conventional debt securities, the securities do not pay interest, do not guarantee the repayment of principal at maturity and are subject to potential automatic early redemption on a periodic basis on the terms described below. Your return on the securities will depend solely on the performance of the **worst performing** of the underlyings specified below.

The securities offer the potential for automatic early redemption at a premium following the first valuation date (other than the final valuation date) on which the closing value of the worst performing underlying on that valuation date is greater than or equal to its initial underlying value. If the securities are not automatically redeemed prior to maturity, the payment at maturity will depend on the closing value of the worst performing underlying on the final valuation date. In this circumstance, at maturity you will be repaid the stated principal amount of your securities *plus* (i) the premium applicable to the final valuation date if the closing value of the worst performing underlying on the final valuation date is greater than or equal to its initial underlying value or (ii) a conditional rebate if the closing value of the worst performing underlying on the final valuation date is greater than or equal to its trigger value but less than its initial underlying value. **However, if the securities are not automatically redeemed prior to maturity and the closing value of the worst performing underlying on the final valuation date is less than its trigger value (which means that the worst performing underlying has depreciated by more than the buffer amount specified below from the strike date to the final valuation date), you will lose more than 1% of the stated principal amount of your securities for every 1% by which that depreciation exceeds the buffer amount. Accordingly, the lower the closing value of the worst performing underlying on the final valuation date, the less benefit you will receive from the buffer. There is no minimum payment at maturity.**

You will be subject to risks associated with each of the underlyings and will be negatively affected by adverse movements in any one of the underlyings. Although you will have downside exposure to the worst performing underlying, you will not receive dividends or participate in any appreciation of any of the underlyings.

Investors in the securities must be willing to accept (i) an investment that may have limited or no liquidity and (ii) the risk of not receiving any payments due under the securities if we and Citigroup Inc. default on our obligations. **All**

payments on the securities are subject to the credit risk of Citigroup Global Markets Holdings Inc. and Citigroup Inc.

Payout Tables and Diagram

The table below illustrates how the amount payable per security will be calculated if the closing value of the worst performing underlying on any valuation date is greater than or equal to its initial underlying value.

If the first valuation date on which the closing value of the worst performing underlying on that valuation date is greater than or equal to its initial underlying value is then you will receive the following payment per \$1,000 security upon automatic early redemption or at maturity, as applicable:
May 21, 2019	\$1,000 + applicable premium = \$1,000 + \$50 = \$1,050
November 21, 2019	\$1,000 + applicable premium = \$1,000 + \$100 = \$1,100
May 21, 2020	\$1,000 + applicable premium = \$1,000 + \$150 = \$1,150

If, on any valuation date, the closing value of any underlying is greater than or equal to its initial underlying value, but the closing value of the other underlying is less than its initial underlying value, you will not receive the premium indicated above following that valuation date. In order to receive the premium indicated above, the closing value of *each* underlying on the applicable valuation date must be greater than or equal to its initial underlying value.

The diagram below illustrates the payment at maturity of the securities, assuming the securities have not previously been automatically redeemed, for a range of hypothetical underlying returns of the worst performing underlying on the final valuation date. Your payment at maturity (if the securities are not automatically redeemed prior to maturity) will be determined solely based on the performance of the worst performing underlying on the final valuation date.

Investors in the securities will not receive any dividends with respect to the underlyings. The diagram and examples below do not show any effect of lost dividend yield over the term of the securities. Hypothetical Examples of the Payment at Maturity

The examples below illustrate how to determine the payment at maturity on the securities, assuming the securities are not automatically redeemed prior to maturity and the closing value of the worst performing underlying on the final valuation date is less than its initial underlying value. The examples are solely for illustrative purposes, do not show all possible outcomes and are not a prediction of any payment that may be made on the securities.

The examples below are based on the following hypothetical values and do not reflect the actual initial underlying values or trigger values of the underlyings. For the actual initial underlying values and trigger values, see the cover page of this pricing supplement. We have used these hypothetical values, rather than the actual values, to simplify the calculations and aid understanding of how the securities work. However, you should understand that the actual payments on the securities will be calculated based on the actual initial underlying value and trigger value of each underlying, and not the hypothetical values indicated below.

Underlying	Hypothetical initial underlying value	Hypothetical trigger value
S&P 500 [®] Index	100	80 (80% of its hypothetical initial underlying value)
Russell 2000 [®] Index	100	80 (80% of its hypothetical initial underlying value)

The examples below are intended to illustrate how, if the securities are not automatically redeemed prior to maturity, your payment at maturity will depend on the closing value of the worst performing underlying on the final valuation date. Your actual payment at maturity per security (assuming the securities are not automatically redeemed prior to maturity) will depend on the actual closing value of the worst performing underlying on the final valuation date.

Example 1—Upside Scenario.

Underlying	Hypothetical closing value on the final valuation date	Hypothetical underlying return
S&P 500 [®] Index	110	10%
Russell 2000 [®] Index	90	-10%

In this example, the Russell 2000[®] Index has the lowest underlying return and is, therefore, the worst performing underlying on the final valuation date. Because the closing value of the worst performing underlying on the final valuation date is less than its initial underlying value but greater than its trigger value (which means that the worst performing underlying has not depreciated by more than the buffer amount from the strike date to the final valuation date), you would be repaid the stated principal amount of \$1,000 per security *plus* the conditional rebate, for a total payment at maturity of \$1,082.

Example 2—Downside Scenario A.

Underlying	Hypothetical closing value on the final valuation date	Hypothetical underlying return
S&P 500® Index	60	-40%
Russell 2000® Index	80	-20%

In this example, the S&P 500® Index has the lowest underlying return and is, therefore, the worst performing underlying on the final valuation date. Because the closing value of the worst performing underlying on the final valuation date is less than its trigger value (which means that the worst performing underlying has depreciated by more than the buffer amount from the strike date to the final valuation date), you would receive a payment at maturity per security that is significantly less than the stated principal amount, calculated as follows:

Payment at maturity per security = \$1,000 + [\$1,000 × the buffer rate × (the underlying return of the worst performing underlying on the final valuation date + the buffer amount)]

$$= \$1,000 + [\$1,000 \times 125\% \times (-40\% + 20\%)]$$

$$= \$1,000 + [\$1,000 \times 125\% \times (-20\%)]$$

$$= \$1,000 + -\$250$$

$$= \$750$$

In this example, you would incur a significant loss based on the performance of the worst performing underlying on the final valuation date. Because the closing value of the worst performing underlying on the final valuation date is less than its trigger value, you will lose more than 1% of the stated principal amount of your securities for every 1% by which the closing value of the worst performing underlying on the final valuation date has declined beyond the buffer amount.

Example 3—Downside Scenario B.

Underlying	Hypothetical closing value on the final valuation date	Hypothetical underlying return
S&P 500 [®] Index	80	-20%
Russell 2000 [®] Index	30	-70%

In this example, the Russell 2000[®] Index has the lowest underlying return and is, therefore, the worst performing underlying on the final valuation date. Because the closing value of the worst performing underlying on the final valuation date is less than its trigger value (which means that the worst performing underlying has depreciated by more than the buffer amount from the strike date to the final valuation date), you would receive a payment at maturity per security that is significantly less than the stated principal amount, calculated as follows:

Payment at maturity per security = \$1,000 + [\$1,000 × the buffer rate × (the underlying return of the worst performing underlying on the final valuation date + the buffer amount)]

$$= \$1,000 + [\$1,000 \times 125\% \times (-70\% + 20\%)]$$

$$= \$1,000 + [\$1,000 \times 125\% \times (-50\%)]$$

$$= \$1,000 + -\$625$$

$$= \$375$$

In this example, you would incur a significant loss based on the performance of the worst performing underlying on the final valuation date. Because the closing value of the worst performing underlying on the final valuation date is

less than its trigger value, you will lose more than 1% of the stated principal amount of your securities for every 1% by which the closing value of the worst performing underlying on the final valuation date has declined beyond the buffer amount. A comparison of this example with the previous example illustrates the diminishing benefit of the buffer the greater the depreciation of the worst performing underlying on the final valuation date.

Summary Risk Factors

An investment in the securities is significantly riskier than an investment in conventional debt securities. The securities are subject to all of the risks associated with an investment in our conventional debt securities (guaranteed by Citigroup Inc.), including the risk that we and Citigroup Inc. may default on our obligations under the securities, and are also subject to risks associated with each underlying. Accordingly, the securities are suitable only for investors who are capable of understanding the complexities and risks of the securities. You should consult your own financial, tax and legal advisors as to the risks of an investment in the securities and the suitability of the securities in light of your particular circumstances.

The following is a summary of certain key risk factors for investors in the securities. You should read this summary together with the more detailed description of risks relating to an investment in the securities contained in the section “Risk Factors Relating to the Securities” beginning on page EA-7 in the accompanying product supplement. You should also carefully read the risk factors included in the accompanying prospectus supplement and in the documents incorporated by reference in the accompanying prospectus, including Citigroup Inc.’s most recent Annual Report on Form 10-K and any subsequent Quarterly Reports on Form 10-Q, which describe risks relating to the business of Citigroup Inc. more generally.

You may lose a significant portion or all of your investment. Unlike conventional debt securities, the securities do not provide for the repayment of the stated principal amount at maturity in all circumstances. If the securities are not automatically redeemed prior to maturity, your payment at maturity will depend on the closing value of the worst performing underlying on the final valuation date. If the closing value of the worst performing underlying on the final valuation date is less than its trigger value, you will lose more than 1% of the stated principal amount of the § securities for every 1% by which the worst performing underlying on the final valuation date has depreciated by more than the buffer amount. You should understand that any decline in the closing value of the worst performing underlying on the final valuation date beyond the buffer will result in a magnified loss to your investment by the buffer rate, which will progressively offset any protection that the buffer amount would offer. The lower the closing value of the worst performing underlying on the final valuation date, the less benefit you will receive from the buffer. There is no minimum payment at maturity on the securities, and you may lose up to all of your investment.

The initial underlying values, which have been set on the strike date, may be higher than the closing values of the underlyings on the pricing date. If the closing values of the underlyings on the pricing date is less than the § initial underlying values that were set on the strike date, the terms of the securities may be less favorable to you than the terms of an alternative investment that may be available to you that offers a similar payout as the securities but with the initial underlying values set on the pricing date.

§ **The trigger feature of the securities exposes you to particular risks.** If the closing value of the worst performing underlying on the final valuation date is less than its trigger value, you will lose more than 1% of the stated principal amount of the securities for every 1% by which the worst performing underlying on the final valuation date has depreciated by more than the buffer amount. Although you will be repaid your stated principal amount *plus* the

conditional rebate at maturity if the worst performing underlying on the final valuation date has depreciated from its initial underlying value, but the closing value of the worst performing underlying on the final valuation date is greater than its trigger value, you will have downside exposure to the worst performing underlying on the final valuation date if the closing value of the worst performing underlying on the final valuation date is less than its trigger value. As a result, you may lose your entire investment in the securities.

Your potential return on the securities is limited. Your potential return on the securities is limited to the conditional rebate payable at maturity or the applicable premium payable upon automatic early redemption or at maturity, as described on the cover page of this pricing supplement. If the closing value of the worst performing underlying on the final valuation date is less than its initial underlying value but greater than or equal to its trigger value, you will be repaid the stated principal amount of your securities and will receive the conditional rebate. If the § closing value of the worst performing underlying on one of the valuation dates is greater than or equal to its initial underlying value, you will be repaid the stated principal amount of your securities and will receive the fixed premium applicable to that valuation date, regardless of how significantly the closing value of the worst performing underlying on that valuation date may exceed its initial underlying value. Accordingly, any premium may result in a return on the securities that is significantly less than the return you could have achieved on a direct investment in any or all of the underlyings.

The securities do not pay interest. You should not invest in the securities if you seek current income during the § term of the securities.

The securities are subject to heightened risk because they have multiple underlyings. The securities are more § risky than similar investments that may be available with only one underlying. With multiple underlyings, there is a greater chance that any one underlying will perform poorly, adversely affecting your return on the securities.

The securities are subject to the risks of each of the underlyings and will be negatively affected if any one underlying performs poorly. You are subject to risks associated with each of the underlyings. If any one § underlying performs poorly, you will be negatively affected. The securities are not linked to a basket composed of the underlyings, where the blended performance of the underlyings would be better than the performance of the worst performing underlying alone. Instead, you are subject to the full risks of whichever of the underlyings is the worst performing underlying.

You will not benefit in any way from the performance of any better performing underlying. The return on the § securities depends solely on the performance of the worst performing underlying, and you will not benefit in any way from the performance of any better performing underlying.

You will be subject to risks relating to the relationship between the underlyings. It is preferable from your perspective for the underlyings to be correlated with each other, in the sense that their closing values tend to increase or decrease at similar times and by similar magnitudes. By investing in the securities, you assume the risk that the underlyings will not exhibit this relationship. The less correlated the underlyings, the more likely it is that any one of the underlyings will perform poorly over the term of the securities. All that is necessary for the securities to perform poorly is for one of the underlyings to perform poorly. It is impossible to predict what the relationship between the underlyings will be over the term of the securities. The underlyings differ in significant ways and, therefore, may not be correlated with each other.

The securities may be automatically redeemed prior to maturity, limiting the term of the securities. If the closing value of the worst performing underlying on any valuation date (other than the final valuation date) is greater than or equal to its initial underlying value, the securities will be automatically called for redemption. If the securities are automatically redeemed following any valuation date (other than the final valuation date), they will cease to be outstanding and you will not receive the premium applicable to any later valuation date. Moreover, you may not be able to reinvest your funds in another investment that provides a similar yield with a similar level of risk.

The securities offer downside exposure to the worst performing underlying, but no upside exposure to any underlying. You will not participate in any appreciation in the value of any underlying over the term of the securities. Consequently, your return on the securities will be limited to the conditional rebate at maturity or the applicable premium payable upon an automatic early redemption or at maturity and may be significantly less than the return on any underlying over the term of the securities.

You will not receive dividends or have any other rights with respect to the underlyings. You will not receive any dividends with respect to the underlyings. This lost dividend yield may be significant over the term of the securities. The payment scenarios described in this pricing supplement do not show any effect of such lost dividend yield over the term of the securities. In addition, you will not have voting rights or any other rights with respect to the underlyings or the stocks included in the underlyings.

The performance of the securities will depend on the closing values of the underlyings solely on the valuation dates, which makes the securities particularly sensitive to volatility in the closing values of the underlyings on or near the valuation dates. Whether the securities will be automatically redeemed prior to maturity will depend on the closing values of the underlyings solely on the valuation dates (other than the final valuation date), regardless of the closing values of the underlyings on other days during the term of the securities. If the securities are not automatically redeemed prior to maturity, what you receive at maturity will depend solely on the closing value of the worst performing underlying on the final valuation date, and not on any other day during the term of the securities. Because the performance of the securities depends on the closing values of the underlyings on a limited number of dates, the securities will be particularly sensitive to volatility in the closing values of the underlyings on or near the valuation dates. You should understand that the closing value of each underlying has historically been highly volatile.

The securities are subject to the credit risk of Citigroup Global Markets Holdings Inc. and Citigroup Inc. If we default on our obligations under the securities and Citigroup Inc. defaults on its guarantee obligations, you may not receive anything owed to you under the securities.

The securities will not be listed on any securities exchange and you may not be able to sell them prior to maturity. The securities will not be listed on any securities exchange. Therefore, there may be little or no secondary market for the securities. CGMI currently intends to make a secondary market in relation to the securities and to provide an indicative bid price for the securities on a daily basis. Any indicative bid price for the securities provided by CGMI will be determined in CGMI's sole discretion, taking into account prevailing market conditions and other § relevant factors, and will not be a representation by CGMI that the securities can be sold at that price, or at all. CGMI may suspend or terminate making a market and providing indicative bid prices without notice, at any time and for any reason. If CGMI suspends or terminates making a market, there may be no secondary market at all for the securities because it is likely that CGMI will be the only broker-dealer that is willing to buy your securities prior to maturity. Accordingly, an investor must be prepared to hold the securities until maturity.

The estimated value of the securities on the pricing date, based on CGMI's proprietary pricing models and our internal funding rate, is less than the issue price. The difference is attributable to certain costs associated with selling, structuring and hedging the securities that are included in the issue price. Moreover, the estimated value of the securities set forth on the cover page of this pricing supplement may differ from the value that we or our affiliates may determine for the securities for other purposes, including for accounting purposes. You should not invest in the securities because of the estimated value of the securities. Instead, you should be willing to hold the securities to maturity irrespective of the initial estimated value.

The estimated value of the securities would be lower if it were calculated based on our secondary market rate.

The estimated value of the securities included in this pricing supplement is calculated based on our internal funding rate, which is the rate at which we are willing to borrow funds through the issuance of the securities. Our internal funding rate is generally lower than our secondary market rate, which is the rate that CGMI will use in determining the value of the securities for purposes of any purchases of the securities from you in the secondary market. If the § estimated value included in this pricing supplement were based on our secondary market rate, rather than our internal funding rate, it would likely be lower. We determine our internal funding rate based on factors such as the costs associated with the securities, which are generally higher than the costs associated with conventional debt securities, and our liquidity needs and preferences. Our internal funding rate is not an interest rate that is payable on the securities.
