For each \$1,000 stated principal amount note you hold at maturity, you will receive an amount in cash determined as follows:

If the final index level is **greater than** the initial index level:  
 $\$1,000 + (\$1,000 \times \text{the index return} \times \text{the upside participation rate})$ , subject to the maximum return at maturity

**Payment at maturity:**

If the final index level is **less than or equal to** the initial index level:  
 $\$1,000 + (\$1,000 \times \text{the index return})$ , subject to the minimum payment at maturity

**If the final index level depreciates from the initial index level, you will be exposed to the first 5% of that depreciation and your payment at maturity will be less than the stated principal amount per note. ### **Selected Risk Considerations**

If the final index level of the underlying index is less than the initial index level, you will lose 1% of the stated principal amount of the notes for every 1% by which the final index level is less than the initial index level, subject to a maximum loss of 5% of your investment.

Your payment at maturity depends on the closing level of the underlying index on a single day.
