# **PPL Corporation**

## **Common Stock**

---

PPL Corporation, or PPL, is selling 236 shares of its common stock to holders of its Premium Equity Participating Security Units (PEPS<sup>SM</sup> Units), Series B, referred to as the PEPS Units, Series B, pursuant to the election by such holders to effect an early cash settlement of their PEPS Units, Series B under the terms thereof. PPL expects to receive approximately \$15,000 in cash proceeds (before giving effect to cash in lieu of fractional shares which PPL will pay to such holders) for the shares of common stock and will use these proceeds for general corporate purposes. See Description of PPL Corporation's Capital Stock in the accompanying prospectus for a description of the PPL common stock to be issued.

Our common stock is traded on the New York Stock Exchange under the symbol PPL. On May 10, 2004, the last reported sale price of our common stock on the New York Stock Exchange was \$40.56 per share.

PPL expects to deliver the shares to purchasers on or about May 12, 2004.
