As previously disclosed in the periodic reports filed by M.D.C. Holdings, Inc. (the Company), during the 2010 first quarter the Company reached a settlement with the Internal Revenue Service ( IRS ) on the audit of its 2004 and 2005 federal income tax returns, which settlement was subject to review by the Joint Committee on Taxation. On August 27, 2010, the Company received a letter from the IRS communicating that the IRS Appeals Office cannot enter into the settlement on the basis reached in the post-appeals mediation. The Company is currently considering its options. No adverse financial statement impact is expected to occur due to reserves and deposits made in prior periods.
