This Pricing Supplement relates to the original issuance and sale by Centex Corporation of the \$170,000,000 Senior Medium-Term Notes, Series E (the Notes), described herein through Banc of America Securities LLC and Credit Suisse First Boston, as agents. We may issue Senior Medium-Term Notes, Series E, and Subordinated Medium-Term Notes, Series E, under Registration Statement No. 333-49966 and Registration Statement No. 333-122355 in a principal amount of up to \$377,000,000 in gross proceeds and, to date, including this offering, an aggregate of \$377,000,000 has been issued.
