Fir Tree may be deemed to beneficially own the shares of Common Stock held by Sapling and Fir Tree Recovery as a result of being the investment manager of Sapling and Fir Tree Recovery.
- (b) Sapling and Fir Tree Recovery are the beneficial owners of 4.7% and 1.2%, respectively, of the outstanding shares of Common Stock. Collectively, the Reporting Persons beneficially own 750,000 shares of Common Stock which represent 5.9% of the shares of Common Stock outstanding. These percentages are determined by dividing the number of shares beneficially held by 12,700,000, the number of shares of Common Stock issued and outstanding, as reported in the Issuer s Prospectus filed pursuant to Rule 424(b)(4) filed with the Securities and Exchange Commission on February 9, 2007.
- (c) Sapling may direct the vote and disposition of 596,420 shares of Common Stock. Fir Tree Recovery may direct the vote and disposition of 153,580 shares of Common Stock. Fir Tree has been granted investment discretion over the shares of Common Stock held by Sapling and Recovery.
