 - (1) Vesting of 29,240 restricted stock units exempt pursuant to Rule 16b-3. The restricted stock units were acquired upon payout of 40% (58,480 units) of the earned performance share award under a shareholder-approved benefit plan. The payout was based on the level of achievement of financial targets for the performance period ended September 30, 2016. The restricted stock units were subject to a one-year vesting period. The payout of the other 60% was previously reported. Of the 58,480 earned units, the reporting person previously transferred the economic interests of 29,240 units to his ex-wife pursuant to a domestic relations order. Mr. Monser disclaims beneficial ownership of such units and does not report them as beneficially owned.
 - (2) Price is not applicable to the acquisition or vesting of the restricted stock units described in Note 1 or to the acquisition of Issuer common stock upon such vesting.
