On August 6, 2013, Harbinger Group Inc.'s majority-owned subsidiary, Spectrum Brands, Inc. ("Spectrum"), issued a press release announcing its intention to commence a tender offer for any and all of Spectrum's outstanding 9.500% Senior Secured Notes due 2019 (the "SPB Notes"), as well as to solicit consents to the adoption of certain proposed amendments to the indenture governing the SPB Notes to, among other things, eliminate substantially all of the restrictive covenants, certain events of default and other related provisions, and release the collateral currently securing the Notes. Spectrum's obligation to accept for purchase and to pay for the SPB Notes in the tender offer and the consent solicitation is subject to the satisfaction of certain conditions. Interested parties should read Spectrum's announcements and public filings regarding the SPB Notes tender offer and the consent solicitation.
