This Registration Statement is being filed by MoSys, Inc. (the Registrant) relating to 2,000,000 shares of its common stock, \$0.01 par value per share (the Common Stock) issuable to eligible individuals under the Registrant's 2010 Employee Stock Purchase Plan (the Plan), and such shares are in addition to shares originally registered on the Registration Statements on Form S-8 filed with the Securities and Exchange Commission (the SEC) on July 28, 2010 (Commission File No. 333-168358).
