On November 17, 2014, salesforce.com, inc. (the “Company”) authorized George Hu, the Company’s Chief Operating Officer, to take a personal leave of absence for up to six months commencing December 2, 2014 . During the leave of absence, Mr. Hu will not receive a salary, and the Company will continue to pay Mr. Hu’s medical and life insurance benefits. Mr. Hu will remain eligible to receive a pro-rated bonus payment with respect to the Company’s fiscal year ending January 31, 2015.
