- (1) On August 8, 2007, Mr. Martin received a grant of performance-based restricted stock units ("RSUs") that, following the completion of fiscal year 2008, were determined by the Compensation Committee of KLA-Tencor's Board of Directors (in August 2008) to cover, based on KLA-Tencor's financial performance during fiscal year 2008, 3,922 shares of KLA-Tencor common stock. On August 8, 2011, Mr. Martin vested in the remaining fifty percent (50%) of such RSUs.
- (2) Pursuant to the terms of the August 8, 2007 performance-based RSU grant, 916 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. The fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on such vesting date.
- (3) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.
