<b>Series:</b>	The Notes are part of a series of debt securities entitled Medium-Term Notes, Series A that we may issue under the Indenture.  We may reopen this series of Notes, and issue additional Notes of this series, under the Indenture in the future.
<b>Interest Payment Dates:</b>	Interest will be paid semiannually on August 1 and February 1, beginning on February 1, 2012, to holders of record as of the preceding January 15 and July 15, respectively.
<b>Day Count:</b>	30/360
<b>Use of Proceeds:</b>	The net cash proceeds from the sale will be used for general corporate purposes. Pending such use, we may temporarily invest net proceeds in interest-bearing, investment-grade securities.

**Settlement Date:**

It is expected that the delivery of the Notes will be made against payment for the Notes on August 1, 2011, which is the third business day after the allocation of the Notes by our auction agent (the settlement cycle being referred to as T+3).
