These measures consist of (i) annual revenue growth and (ii) annual "pro forma" net income growth, assessed each fiscal year over a period of four years. The number of performance-based shares is the target number of shares. The actual number of shares to be vested may be more or less than the target number, based on over- or under-achievement of the identified corporate performance measures, ranging from 150% to 0%.
