Paul Calello, Chairman of Credit Suisse's Investment Bank and member of the Executive Board, dies at age 49

Zurich, November 16, 2010 Credit Suisse announced today that Paul Calello, Chairman of the Investment Bank of Credit Suisse and a member of the Bank's Executive Board, died today in New York, of non-Hodgkin's Lymphoma. He was 49 years old. He is survived by his wife, Jane deBevoise, and their four children.

Brady W. Dougan, CEO of Credit Suisse Group, said: "Paul Calello was an outstanding leader and a down-to-earth, very human colleague who forged strong relationships and made a positive difference in the world around him. We will miss him greatly, but his spirit and accomplishments will remain a part of Credit Suisse. Our thoughts are with his family today."

Mr. Dougan continued: "Paul made an enormous contribution to Credit Suisse and the financial industry over many years. He played a pivotal role in the creation of the equity derivatives market, and as a founding member of Credit Suisse Financial Products, helped build it into one of the most significant derivatives firms in the industry. He ran many important businesses for Credit Suisse and expanded our presence globally, most notably in Asia Pacific, where he led Credit Suisse's dramatic growth across the region. In 2007, Paul was named CEO of the Investment Bank and did an incredible job, working with his management team, to navigate the market crisis and bring the franchise out of the downturn stronger and well positioned for the new environment."
