Sabby Management, LLC, a Delaware limited liability company, indirectly owns 2,736,714 shares of Common Stock because it serves as the investment manager of Sabby Healthcare Volatility Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd., Cayman Islands companies that directly hold 2,000,000 and 736,714 shares of Common Stock, respectively. Mr. Mintz indirectly owns 2,736,714 shares of Common Stock in his capacity as manager of Sabby Management, LLC.
