- (3) Pursuant to such terms of the February 6, 2013 RSU grant, 2,406 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. The fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on such determination date (February 5, 2016).
- (4) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.
